## 12. Determination of Affiliation fees for the 2020/21 financial year

THAT the Affiliation fee for 2020/21 financial year be set at \$34.41 plus GST for Adults 35+, Adults 19-34, Juniors 12-18 (all as at 30/04/2021) and at \$25.60 plus GST for Juniors 11 & under (as at 30/04/2021).

This represents a decrease of 5% on the previous affiliation fee on the Tennis Auckland fee component. Also, a decrease of 30% on the Tennis NZ fee component. There will be no upward adjustment for annual CPI of 1.8% this year.

For the following 2021/22 season, the **Tennis Auckland fee component** will return to the 2019-20 level (\$23.86) plus CPI for the three quarters to June 2021 + GST. This guidance is provided to clubs now via a decision at the 2020 AGM (the only time we can set fees) and to be confirmed at a Delegates Meeting in Feb/March 2021. This is so clubs can set their membership fees for the 2021/22 season well before their own AGM.
